Other Fees		
Deposit	\$1,500	A non-refundable and non-transferable deposit is required for each student.
Enrollment Fee	\$1,200	A one-time enrollment fee is required for each student for the administrative process.
Protect My Tuition Refund Insurance Plan (TRP) Fee	2.25%	The purpose of the plan is to protect both the School and parents in case a student decides to withdraw or is dismissed from the program. The insurance provides coverage for a part of the program fee commitment in case the child's enrollment ends due to illness, covered reasons for withdrawal, or dismissal. You can refer to the Protect My Tuition Brochure for additional details. The Protect My Tuition Insurance Refund Plan costs 2.25% of the academic program fee and should be paid along with the May 2024 installment. Please note that this insurance policy does not cover fees for Summer, Additional Care Options, Music, Material, Activity & Technology, Enrollment, or any other assessed fees.

Payment Schedules

Our school uses TADS, a secure online tuition management service provider for processing enrollment and the payment of tuition and fees. Further information regarding creating a TADS account will be provided at the time of enrollment.

Enrollments submitted before **May 15th, 2024** require a payment for the non-refundable and non-transferable deposit of \$1,500.

Enrollments submitted after May 15th, 2024, require the following payments:

- A non-refundable and non-transferable deposit of \$1,500, which is included in the overall program fee.
- A one-time enrollment fee of \$1,200.
- Tuition Refund Insurance Fee (TRP).
- Any past due payments (reflected in the payment options below)
