1) pre-screening; 2) screening; 3) social distancing; 4) cohorting; 5) masking; 6) hygiene; 7) disinfection; and 8) illness & isolation

School Health & Safety Plan

1 Pre-Screening

All: All health forms need to be received by the health office no later than two days before the child begins. No exceptions. All immunizations must be up to date. All required medications must be in the health office 2 days prior to the child's start date.

Attendance will be taken daily and reported to the main office. If a child will be absent, we ask parents to inform the school by emailing their child's name to absences@princetonmontessori.org and including a reason for the absence, i.e, sickness, vacation, family event, etc. Absence notifications will be forwarded to the correct child's conference teacher.

Children: To protect the health of all of our community and to prevent the spread of infection, parents must report to the school immediately if the child or any person in the child's household has or is suspected to have COVID-19. State and federal regulations and guidelines will be followed and confidentiality will be protected to the greatest extent possible.

Faculty/staff: Faculty/staff must report to the school immediately if they or any person in their household

		has or is suspected to have COVID-19, or has any of the following symptoms: fever, shortness of breath, sore throat, cough, temperature, loss of smell, loss of taste, myalgia, fatigue, nausea, diarrhea.
2	Screening	Children: Temperature checks for all students will be conducted daily at drop-off, while they are still with their parents, so that if there is a fever, they can go straight home. Any student with a temperature equal to or higher than 100.4 will be sent home.
		Faculty/staff: Temperature checks will be completed independently as faculty and staff arrive. Any faculty or staff with a temperature equal to or higher than 100.4 will be sent home.
3	Social Distancing	Drop off and Pick up: We will minimize parent presence in the building and minimize cross-class exposure during drop off and pick up times by the use of multiple entry and exit points and a refined transition to the classroom for each group. Details of each program's procedures and arrival and dismissal times will be included with program-specific communication.
		Outdoor Classrooms: Each program is equipped with beautiful outdoor classroom space, dedicated to their program. As much as possible, each program will make use of outdoor classroom spaces, weather permitting, to allow children to spread out and enjoy fresh air.
		By Program: Infant - drop off & pick up inside according to child's individual schedule Toddler - drop off & pick up outside at Toddler classroom door Primary - drop off & pick up outside at main school entrance Upper School - drop off & pick up outside at lower parking lot
		Visitors: Non-essential visits will be significantly limited and, if deemed safe, carefully arranged. When we are able to, we will have essential visitors and service-providers come during hours when children are not present. When we are not able to, visitors shall be scheduled and escorted so that they will not come within six feet of students and non-visit related employees. All visitors shall be subject to the same screening procedures as children and staff.
		We will not have field trips this year, nor bring visiting presenters to campus.

4	Cohorting	 Cohorts are defined as 'classes' for our school. Each class will stay separate from the other classes, with their own learning environments as well as staggered use of the playground. Shared multi-use rooms will be disinfected and ventilated between use. We will maximize being outdoors, as weather permits, and will ensure adequate ventilation when indoors. Children and teachers will have close contact, but each classroom will function as an independent unit, and be socially distant from other classrooms, administration, and facilities, as much as is possible. We want the children in the classroom to be comfortable and able to freely move, learn, and interact. Keeping children in smaller cohorts reduces overall risk of transmission. Due to cohorting, we will not offer clubs this year. See details about extended day and specials changes on the program-specific section.
5	Masking	 Parents - Parents will wear a mask when dropping-off and picking-up. Parents will not come inside the building unless absolutely necessary and if they do, they will mask. Administrators - Inside, administrators will wear masks when walking through the building or not alone in their offices. Outside, administrators should always mask, as an extra precaution, as we are engaging with cohorts we are not a part of. Substitutes - Substitutes, because they are exposed to multiple cohorts, will wear a mask at all times, indoors and out, and try to limit close contact with children and staff. Faculty - Indoors, teachers will wear a mask at all times. Outdoors, masks will be worn when getting closer than 3 feet distance from each other for more than 15 minutes, which is the contact tracing definition of risked exposure. (as per American Academy of Pediatrics and National Academy of Sciences guidelines) Children -
		 Indoors, children, two years of age and older, will wear masks except when eating or drinking. Children will never wear masks during nap times. During eating, drinking, and nap time, distance between children will be maximized and other measures may be taken as they are available, depending on if we are inside or outside.

		 Outdoors, with activities that DO NOT INVOLVE heavy breathing, masks will be worn when getting closer than 3 feet distance from each other, particularly if contact is for more than a 15 minutes of exposure. (as per American Academy of Pediatrics and National Academy of Sciences guidelines) Outdoors, with activities that DO INVOLVE heavy breathing, such as singing or fitness, masks will be worn when getting closer than 6 feet distance from each. Education on mask wearing will occur in all programs. Note that indoor gym classes will not occur, even with masking, as anything that results in heavy breathing in an enclosed space increases the risk of transmission.
6	Hygiene	 All faculty, staff, and children will wash hands thoroughly and properly upon entering the building, and frequently throughout the day, according to what is appropriate for that age group and recommended by the CDC. Teachers are responsible for setting and maintaining these routines. Certain individual supplies will be provided to children, such as: scissors, pencils, markers, glue, playdough. Students will wash hands before selecting a work and disinfecting of materials will happen as often as possible. High-contact shared objects, such as door knobs and sink handles, will be cleaned throughout the day and all shared materials will be, once again, thoroughly disinfected at the end of each day. We will not offer food work. Students will bring their own lunches and utensils from home, with the exception of the Toddler lunch program. As part of reducing the potential for transmission, children will eat snack and lunch outside when feasible. Snacks may be left out for kids to elect to take for short periods of time. Seating arrangements for eating will be arranged to maximize distance from others. Clothing and other student materials will be stored individually in the child's cubby or locker.
7	Disinfecting	 Cleaning will occur in the classrooms multiple times during the day both to clean and disinfect high touchpoint items. Each evening, our cleaning company will perform nightly cleaning and disinfecting throughout the building. There will be weekly electrostatic disinfection, using spray mist, by City Wide Cleaners. iWave AdvantageAir Purification Bi-Polar Ionization units are installed in our HVAC units. The iWave approach produces equal amounts of positive and negative ions that break down pathogens, allergens,

		particles, smoke, odors and VOCs in the air, creating a healthy environment without producing any harmful byproducts.
8	Illness & Isolation	 Any child who exhibits signs of illness during the day will immediately be brought to the health office for further evaluation and isolation. If the child exhibits a fever or is deemed to be too ill to remain at school, a parent will be called to pick the child up. The child will remain in the health office, isolated from other students, until a parent can arrive. Parents are asked to ensure they have someone on their contact list that can be at the school to pick up within 30 minutes. Students with a fever will need to remain at home and be fever-free (without fever-reducing medication) for 72 hours (3 days) before returning to school. Faculty or staff who are ill will also be sent home and asked to monitor for Covid-19 symptoms and will not return to work until cleared. The school will immediately notify our county department of health of any known or suspected COVID-19 exposure in the program facility. We will follow state guidelines on partial or full closure of programs should someone in our community have a confirmed case of Covid-19. The community will be notified should a positive case of Covid-19 be confirmed in our community. Any employee who has a family member who has tested positive for Covid-19, or have themselves come in close contact (defined by closer than 6 feet for more than 15 minutes) with someone who has tested positive for Covid-19, should not come to campus until 14 days have passed.
